## **Terms & Conditions**

Please note that this competition is open to all ages however, if you are under the age of 18, we will require you to provide express permission of a parent or guardian on your behalf in order to be entered.
- 2. There is no entry fee and no purchase necessary to enter this competition.
- 3. Submissions are to be made via OpenWeather website. The opening date for submissions will be at 9.00 am on 02.04.2024.
- 4. Only one entry will be accepted per individual. Multiple entries by the same individual will result in disqualification.
- 5. The closing date for entry will be by 00.00 on 15.05.2024. After this time, no further entries to the competition will be permitted, and no responsibility is accepted by Openweather for entries which were not received on time.
- 6. The Winner shall be announced on The Royal Meteorological Society Early Career and Student Conference 2024 that will take place at the Met Office on the 1-3<sup>rd</sup> of July and the prizes will be awarded as follows: £1000 for first place, £500 for second place, and £300 for third place. The prize is non-transferable and no other alternatives will be offered. Openweather is not responsible for any inaccurate prize descriptions supplied to any entrant by a third party connected with this competition.
- 7. The Winner will be notified within 28 days of the closing date. If the Winner cannot be contacted or does not claim the prize within 14 days of being notified, we reserve the right to withdraw the prize from the Winner and pick a replacement Winner.
- 8. By entering into this competition, the entrant agrees that:
